THE FREDERICTON HISTORICAL SOCIETY (instituted December 22nd, 1881) has been formed with the object of gathering together any and all Documents, Papers and Manuscripts which bear or throw light on the history of the Province, with a view to their preservation and chronological arrangement; and, also, of collecting materials, of the present and passing day, for the writing of its history in the future—such as Pamphlets, Reports of all kinds, Books, Legislative Docu-
