HIS Honor the Lieutenant Governor directs the publication of the following for general information.

My Lord,—With reference to my Circular Despatch of this day's date, conveying authority to the Governors of Her Majesty's Colonies to issue to Aliens, naturalized in the Colonies, Passports unlimited in point of duration, instead of for one year as heretofore, I have the honor to acquaint you that, in the case of Canada, this authority extends to the Lieutenant Governors of the Dominion, and Passports issued by them will be recognized by Her Majesty's Ministers and Consuls abroad. You will be so good as to cause the Lieutenant Governors to be informed to this effect.

Passports to Naturalized British Subjects in the Colonies.

Governors are authorized to issue Passports for foreign travel to persons naturalized in their respective Colonies.

The form of Passport is inserted in the Appendix (page 317). These Passports must be signed by the Officer administering the Government, and must contain an express declaration that the person receiving the Passport has been naturalized as a British subject in the Colony.
