## LEGISLATIVE COUNCIL CHAMBER,

FREDERICTON, THURSDAY, APRIL 6, 1882.

THIS day, at four o'clock, P. M., His Honor The Honorable ROBERT DUNCAN WILMOT, Lieutenant Governor of the Province of New Brunswick, came to the Council Chamber, and being seated on the Throne, commanded the attendance of the House of Assembly, who being come, His Honor, after assenting to the several Bills passed, was pleased to close the Session with the following

### S P E E C H :

*" Mr. President, and Honorable Gentlemen of the Legislative Council,*

*" Mr. Speaker, and Gentlemen of the House of Assembly,*

" My acknowledgments are due to you for the attention which you have paid to the general business of the Session, as well as to those subjects which from time to time I have submitted to you. As you are intimately acquainted with the condition and requirements of the Province, I sincerely hope that the questions which have received your consideration have been disposed of in a manner most accordant with its best interests.

*" Mr. Speaker, and Gentlemen of the House of Assembly,*

" I thank you for the liberal provision you have made for Great Works, and for the usual services of the Public. It will be my effort to administer your legislation, and to apply your appropriations to their respective objects, with due attention to that proper economy which appears to me to consist in giving full effect to the service in view, without unnecessarily or unduly burdening the resources or revenues of the Province.

*" Mr. President, and Honorable Gentlemen of the Legislative Council,*

*" Mr. Speaker, and Gentlemen of the House of Assembly,*

" I congratulate you upon the conclusion of your arduous labors, and upon the very satisfactory state in which you have found the Finances and general affairs of the Province. I relieve you from further attendance upon your duties here, and I earnestly pray that it shall please Providence to continue to us the many blessings we now enjoy, and to graciously crown the interests and industries of the Province with success during the ensuing year."

After which, the Honorable the President of the Legislative Council, by His Honor's command, declared the Assembly prorogued to the third Tuesday in May next.

The following is a List of the Acts passed at the recent Session of the Legislature:—

*Passed 21st March 1882.*

An Act to declare valid the Lists of Electors made up during the year one thousand eight hundred and eighty one, by Revisors in the several Parishes of this Province.

An Act to amend an Act intituled An Act to incorporate certain Districts of the Parish of Saint Stephen, in the County of Charlotte, to be known as the Town of Milltown.

An Act to amend Chapter 99 of The Consolidated Statutes, of 'Municipalities,' and Chapter 75 of 41st Victoria, intituled An Act relating to Highways in the Parishes of Simonds, Saint Martins, Lancaster, and Musquash, in the City and County of Saint John.

*Passed 6th April 1882.*

An Act to provide for the repair and improvement of Roads and Bridges, and other Public Works and Services.

An Act to provide for defraying certain expenses of the Civil Government of the Province.
