LEGISLATIVE COUNCIL CHAMBER,

Saturday, 3rd March, 1883.

This day, at twelve o'clock, noon, His Honor The Honorable ROBERT DUNCAN WILMOT, Lieutenant Governor of the Province of New Brunswick, came to the Council Chamber, and being seated on the Throne, commanded the attendance of the House of Assembly, who being come, His Honor was pleased to deliver the following

S P E E C H :

"Mr. President, and Honorable Gentlemen of the Legislative Council,

"Mr. Speaker, and Gentlemen of the House of Assembly,

"The resignation of the late Government since the opening of the Legislature, the formation of a New Administration, and the vacation of several Seats in the Assembly consequent thereupon, have rendered it advisable that your deliberations upon public matters should be postponed until a future day."

After which, the Honorable the President of the Legislative Council, by His Honor's command, declared the General Assembly prorogued to Thursday the 12th day of April next.
