An Act in amendment of Chapter 51 of the Consolidated Statutes, 'County Courts.'

Passed 1st April, 1884.

102

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. There shall be an additional Term of the County Court for the County of Madawaska holden on the fourth Wednesday in March.

2. There shall be an additional Term of the County Court for the County of Victoria holden on the Tuesday after the fourth Wednesday in March.

3. The March Term of the County Court for the County of Charlotte is hereby changed from the fourth Tuesday in

March to the fourth Tuesday in February.

4. It shall be lawful for the County Court before which an indictment shall be presented, or a trial be had, as the case may be, to order the payment of the Fees of the Clerk of the Court as Clerk and not as prosecuting officer; and an order for the payment of such amount shall be forthwith drawn in favor of such Clerk upon the Treasurer, signed by the Judge, and the same shall be paid out of any moneys

belonging to such County in the Treasurer's hands.

5. In case where no Grand Jury has been summoned to attend at the opening of a County Court, or when it shall appear necessary to the Judge, during the sitting of the said Court, to summon a Grand Jury, whether one has or has not been previously summoned and discharged at such sitting, the Judge of the said Court, or other Judge presiding thereat, may direct the summoning of a Grand Jury, and such Grand Jury may be summoned by the Sheriff, or a Coroner to be named by the Judge, and of twenty one Petit Jurors to attend the said Court, and an adjourned Court, in the manner now prescribed by law for summoning Grand and Petit Jurors: Jurors summoned under this Section shall be liable to the same fines and penalties, and entitled to the same immunities as in other cases is provided for relating to Jurors

6. In any and every case of summary conviction or order made under and by virtue of any Act of the Legislature of this Province, or by virtue of any bye law, ordinance or regulation made under the authority of any Act of the Legislature of this Province, before any Justice or Justices of the Peace for any County, or before any Magistrate of a Police Court, or any Stipendiary Magistrate, there shall be the same right of review before any Judge of the Supreme Court, or any Judge of a County Court, in the same manner and with the like powers as is given on review from Judgments in Civil Cases under Chapter 60 of the Consolidated Statutes; and the provisions of said Chapter 60 of the Consolidated Statutes, and other Acts relating to review shall, so far as the same can be made so, be made applicable to proceedings under this Chapter.

7. All the provisions of Section seventeen of Chapter fifty one of the Consolidated Statutes, shall apply as fully to Criminal as Civil cases.
