PROCLAMATION.

WHEREAS the General Assembly of this Province stands prorogued to Thursday the twenty third day of October instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday the twenty seventh day of November next.

Given under my Hand and Seal at Fredericton, the twenty second day of October, in the year of our Lord one thousand eight hundred and eighty four, and in the forty eighth year of Her Majesty's Reign.

Inspectoral Districts.

THE Board of Education has been pleased to make the following Order:—

Ordered, That by virtue of the power vested in the Board of Education under the provisions of the Act of the General Assembly 47th Victoria, Chapter 12, intituled "An Act in amendment of the Law relating to Schools," the number of Inspectors of Schools in the Province is hereby decreased to Six, and the Inspectoral Districts are revised and enlarged, and shall henceforth consist of six Inspectoral Districts, and shall comprise and include the Districts as hereinafter numbered and described; which Districts so hereinafter numbered and described are hereby erected into and declared to be the Inspectoral Districts under the said Act, viz:—

DISTRICT No. 1.—The Counties of Restigouche, Gloucester, Northumberland, and the Parishes of Stanley and Saint Mary's, in the County of York.

DISTRICT No. 2.—The County of Kent, the Parishes of Shediac, Dorchester, and the French Schools in the Parish of Botsford, in the County of Westmorland, the Counties of Victoria and Madawaska, and the Parishes of Aberdeen, Kent, and Wicklow, in the County of Carleton.

DISTRICT No. 3.—The County of Westmorland, (except the Parishes of Shediac, Dorchester, and the French Schools in the Parish of Botsford, and the Schools in the incorporated Town of Moncton), the County of Albert, and the Parishes of Havelock, Cardwell, Waterford, Studholm, Sussex, Hammond, Norton, and Upham, in the County of King's.

DISTRICT No. 4.—The Parishes of Springfield, Kars, Kingston, Hampton, Rothesay, Greenwich, and Westfield, in the County of King's, the County of Queen's, and the Parish of Clarendon, in Charlotte County, the County of Sunbury, and the Parishes of Douglas, Bright, Queensbury, and Southampton, in the County of York.

DISTRICT No. 5.—Saint John City and County, and the County of Charlotte, (except the Parish of Clarendon, and the Schools in the incorporated Towns of Charlotte).

DISTRICT No. 6, OR GRAMMAR SCHOOL INSPECTORATE.—The Grammar Schools of the Province, the Schools in the incorporated Towns of the Province, the Schools in the City of Fredericton, and the Schools in the Parishes of New Maryland, Kingsclear, Manners-Sutton, Prince William, Dumfries, Canterbury, and North Lake, in the County of York; and the County of Carleton, except the Parishes of Aberdeen, Kent, and Wicklow.

No. 7.—Any Border School District constitutes a part of the Inspectoral District in which the School House is situate.

This Order shall take effect on the first of November, 1884.
