GNEERAL RULE .- HILARY TERM, 1884.

WHERE the Attorneys for the respective parties reside in the same County, but more than ten miles distant from each other, the defendant's Attorney shall be allowed Four days after demand of Plea, wherein to file the Plea and serve a copy thereof on the plaintiff's Attorney, unless the demand be accompanied by a direction to deliver the copy of Plea to some person resident in the same place in which the defendant's Attorney resides; in which case such copy of Plea must be delivered within twenty four hours, according to the present practice.

WHEREAS it has been made to appear by affidavit to the satisfaction of me, the undersigned, one of the Judges of the Supreme Court, that James Shannahan and Thomas Shannahan, two of the above named defendants, do not reside within the Province, so that they cannot be served with a Summons, and that their and each of their places or place of residence is unknown to the plaintiffs, and each of them, and that the above plaintiffs have good prima facte grounds for filing a Bill against the said defendants, James Shannahan and Thomas Shannahan: I do therefore hereby order that the said defendants, on or before the thirty first day of May next, do enter an appearance in this suit, (if they intend to defend the same), wherein a Bill will be filed against them and the other above named defendants for the foreclosure and sale of certain mortgaged Lands and Premises mentioned and described in two several Indentures of Mortgage, both made between one William Shannahan, of the one part, and the said William H. Scovil, of the other part, one of which said Indentures of Mortgage lears date the first day of May in the year of our Lord one thousand eight hundred and seventy five, and the other of which bears date the thirteenth day of October in the year last aforesaid, in the Equity of Redemption, of which said lands and premises the said James Shannahan and Thomas Shannahan are interested as heirs of one Pitrick Shannahan who died intestate, and who was a devisee under the last Will and Testament of the said William Shannahan, deceased; and unless such an appearance is so entered, the Bill may be taken pro confesso and Decree made.
