## GENERAL RULE .- HILARY TERM, 1884.

WHERE the Amorneys for the respective parties reside in the same County, but more than ten miles distant from each other, the defendant's Attorney shall be allowed Four days after demand of Plea, wherein to file the Plea and serve a copy thereof on the plaintiff's Attorney, unless the demand be accompanied by a direction to deliver the copy of Plea to some person resident in the same place in which the defendant's Attorney resides; in which case such copy of Plea must be delivered within twenty four hours, according to the present practice.
