Your Petitioner further says that the said Thomas l'emple did directly and indirectly by himself by his agent and agents and by other persons on his behalf, with and without his knowledge and consent, before, during and after the said Election corruptly give, lend and agree to give and lend. offer and promise money and valuable considerations, and did promise to procure and to endeavor to procure money and valuable considerations to and for a voter and voters, and to and for a certain person and persons, on behalf of a voter and voters, and to and for a certain person and persons, in order to induce a certain voter and voters' to vote, and in order to induce a voter and voters to refrain from voting, and on account of a voter and voters having voted, and on account of a voter and voters having refrained trom voting at the said Election, whereby the said Thomas Temple was and is incapacitated from serving in the House of Commons of Canada, for the said Electoral District of the County of York, and the said election and return of the said Thomas Temple were and are wholly null and void.

Your Petitioner further says that the said Thomas Temple did by himself, his agent and agents, and by other persons on his behalf, with and without his knowledge and consent, before, during and after the said Election, corruptly give and procure, and agree to give and procure, offer and promise to procure, and endeavour to procure office, place and employment, money and valuable consideration to and for a certain person and persons in order to induce such person and persons to procure or endeavour to procure the return of him, the said Thomas Temple, to serve in the House of Commons of Canada for the said Electoral District of the County of York, and in order to induce such person and persons to procure, and to endeavour to procure the vote of a certain voter, and the votes of certain voters at the said Election, whereby the said Thomas Temple was and is incapacitated from serving in the House of Commons of Canada for the said Electoral District of the County of York, and the said election and return of the said Thomas Temple were

and are wholly null and void.

7. Your Petitioner further says that the said Thomas Temple did by himself, and his agent and agents, and by other persons on his behalf, with and without his knowledge and consent, before, during and after the said Election, advance and pay, and cause to be paid, a certain sum of money, and certain sums of money to and to the use of a certain person and certain persons with intent that such sum of money and sums of money, or part thereof, should be expended in bribery and corrupt practices at the said Election, and knowingly paid and caused to be paid a certain sum of money and certain sums of money to a person and persons in discharge or repayment of money wholly or in part expended in bribery and corrupt practices at the said Election, whereby the said Thomas Temple was and is incapacitated from serving in the House of Commons of Canada for the said Electoral District of the County of York, and the said election and return of the said Thomas

Temple were and are wholly null and void.

8. Your Petitioner further says that the said Thomas Temple did corruptly, by himself, and his agent and agents, and by other person and persons, on his behalf, with and without his knowledge and consent, and by other ways and means on his behalf, before and during the said Election, directly and indirectly give and provide, and cause to be given and provided, and was accessory to the giving and providing, and paid wholly or in part expenses incurred for meat, drink, refreshment and provision to and for a person and persons in order to be elected, and for being elected, and for the purpose of corruptly influencing such person and persons, and some other person and persons to give his and their vote and votes at the said Election, and to refrain from giving his and their vote and votes at the said election, whereby the said Thomas Temple was and is incapacitated from serving in the House of Commons of Canada for the said Electoral District of the County of York, and the said election and return of the said Thomas Temple were and are wholly null and void

9. Your Petitioner further says that the said Thomas Temple did corruptly by himself, by his agent and agents, and by other person and perons on his behalf, with and without his knowledge and consent, directly and indirectly give and cause to be given to a voter and voters on the Nomination Day for the said Election, and on the day of Polling at the said Election, and between such days, on account of such voter and voters having voted and being about to vote, meat, drink and refreshment and money, and a ticket and tickets to enable such voter and voters to procure refreshments, whereby the said Thomas Temple was and is incapacitated from serving in the House of Commons
