SIR,-I have the honor to inform you that the Gilchrist Trustees having taken into their consideration the communications, relative to the Scholarships of the Trust, received from the several Provinces of the Dominion of Canada, and from the Islands of Jamaica, Trinidad and Barbadoes, in the west findes, have decided to withdraw the present triennial Scholarship granted to Nova Scotia, New Brunswick and Prince Edward's surveyed; or if not surveyed, previous to the receipt of the Return of Islands, and the triennial Scholarship granted to the Islands of Island, and Barbadoes, the first named after the Jamaica, Trinidad and Barbadoes, the first named after the award which may be made on the recent examination (June 1887), and the latter, after the award which may be made on the examination which will be held in January next.

Those Scholarships respectively are accordingly so withdrawn, but the Trustees will further consider the subject next Spring, and should they then, or at any future time, institute any other Scholarship or Scholarships for those or any or either of those places, or for any other Province in the Dominion of
