Passed 28th March, 1888.

An Act to authorize the Town of Saint Stephen, in the County of Charlotte, to issue Debentures to provide for the payment of certain Loans for School purposes.

An Act relating to the issue of School Debentures in School District Number One, Parish of Saint George, in the County of Charlotte.

An Act relating to Agriculture.

An Act to incorporate the Saint Stephen Electric Light Company.

An Act to erect part of the Parish of Saint Mary, in the County of Kent, into a separate Parish.

An Act authorizing the lighting of the Town of Newcastle by Electricity.

An Act relating to Retaining Walls within the City of Portland.

An Act to authorize an Assessment for Police purposes, on the Police District of the Town of Newcastle, in the County of Northumberland.

An Act to provide for a special Assessment upon the City of Saint John, to pay for the Paving of a part of Prince William Street, and to amend Chapter 74 of 30th Victoria, relating to Paved Sidewalks in the City of Saint John.

An Act to incorporate the Woodstock Women's Christian Temperance Union.

An Act to incorporate Saint Croix Electric Company.

An Act to incorporate the Saint Andrews Land Company.

An Act to provide for a Commission to enquire and report with a view to the Union of the Cities of Saint John and Portland, in the City and County of Saint John.

An Act relating to Suits in which the City Corporation of Saint John may be a party or interested.

An Act to authorize the City of Fredericton to assess in aid of the Victoria Hospital in said City.

An Act to amend Chapter 100 of the Consolidated Statutes, of 'Rates and Taxes,' so far as relates to King's County.

An Act to incorporate the Parleeville Public Hall Company.

An Act relating to the sale of Estates vested in Trustees, and Estates of Infants.

An Act to provide for the safety of the Public in certain cases.

An Act to incorporate the Railroad Leasing and Traffic Company of New Brunswick (Limited).

An Act to incorporate the Hatfield Point Public Hall Company.

An Act to amend an Act to incorporate the Moncton Harbour Improvement Company.
