NOTICE is hereby given, of intention to apply by Petition under the provisions of "The New Brunswick Joint Stock Companies' Letters Patent Act," for Letters Patent under the Great Seal of the Province of New Brunswick, incorporating the applicants and such other persons as may become Shareholders in the Company thereby created a body politic and corporate under the said Act.

1. The proposed corporate name of the Company is "THE ALGONQUIN HOTEL COMPANY (LIMITED)."

2.
