41. That part of the Parish of Richmond not included in District Number 40, the Parish of Woodstock, in the County of Carleton, and that part of the Parish of Northampton, in the said County, not included in District Number 37.

42. That part of the Parish of Wakefield, in the County of Carleton, fronting on the River Saint John, north of the Second Tier Road (so called), and including the lots fronting on the said road, and the Parishes of Brighton and Peel, in the said County.

43. That part of the Parish of Wakefield not included in District Number 42, and the Parish of Wilmot, in the said County of Carleton, extending as far north as Good's Corner.

44. That part of the Parish of Wilmot not included in District Number 43, the Parish of Wicklow, in the County of Carleton, and the front lots in the Parish of Kent, in the said County.

45. The Parish of Aberdeen, in the County of Carleton, and that part of the Parish of Kent not included in District Number 44.

46. The Parishes of Andover and Perth, in the County of Victoria.

47. The Parishes of Gordon and Lorne, in the County of Victoria.

48. The Parishes of Grand Falls and Drummond, in the County of Victoria.

49. That part of the County of Madawaska which lies south of Green River.

50. That part of the County ef Madawaska not included in District Number 49.

HIS Honor the Lieutenant Governor has been pleased to make and prescribe the following Regulations for the government of Agricultural Societies under the Agricultural Act, 1888 :--

1. When fifty or more persons shall petition the Governor in Council for Letters of Incorporation under the Agricultural Act of 1888, and shall comply with the following conditions, viz :--

(a). Shall, subject to the provisions of Section 11 of these Regulations, subscribe and pay not less than one hundred dollars before the petition is presented to the Governor in Council;

(b). Shall specify the special objects, if any, sought to be promoted by such Society :

promoted by such Society; (c). Shall state the number of the District in which such Society is to be located;

the Governor in Council may issue to the persons named in such petition Letters Patent under the said Act, and the corporate name of such Society shall be "The Agricultural Society of District Number ——."

2. Such petition shall be in the form following :-

To His Honor the Lieutenant Governor in Council.

The Petition of the undersigned respectfully sheweth :

That your petitioners desire to be incorporated under the Agricultural Act of 1388, for District Number —.

That your petitioners have severally subscribed the sums set opposite their respective names hereunder, to be applied to the promotion of the objects of the said proposed corporation; and have paid the same to _____, Provisional prescribe; or in case the society shall have been in operation for less than a year, then such society shall file an account for such part of a year as it has been in operation; and the Secretary for Agriculture on receiving such ac-

3. On receipt of such petition, the same shall be forthwith delivered to the Secretary for Agriculture, who shall immediately prepare a full Report, giving particulars as to the District in which it is proposed that the said Society shall be located, and and other facts that he may be possessed of or which may come to his knowledge, and which in his opinion ought to be considered by the Governor in Council, in connection with the prayer of the said petition; and he shall submit such Report to the Commissioner, and the Commissioner shall present such petition, with the Secretary's Report thereon, to the Governor in Council; and the Governor in Council may thereupon in their discretion grant or refuse the prayer of such petition.

4. The object for which a Society may be incorporated under the said Act shall be as follows :-- The encouragement and promotion of improved methods of dairying, of the breeding of improved stock, of improved methods of fruit raising, and of improved methods of agriculture and horticulture; the dissemination of literature and other information relating to agriculture and stock raising, and generally the promotion of agriculture.

5. Every Society incorporated under the Act shall continue to be a corporation, and be entitled to the benefits of the Act and of these Regulations only so long as it shall, subject to the provisions of Section 11 of these Regulations, have a membership of at least fifty members, and shall raise by subscription the sum of one hundred dollars, on or before the first day of December in each and every year, and the amount of such subscription shall be in the Treasurer's hands by that date.

6. The Governor in Council shall have authority at any time it appears to be in the public interest, or when it shall appear that a society incorporated under the Act is employing its powers and privileges conferred upon it by the Act and these Regulations, in a manner other than is calculated to promote the interests of Agriculture, to cancel the Letters Patent of incorporation of such society; but no Letters Patent shall be cancelled until the grounds of complaint against the society have been communicated in writing to the Secretary of the society, and until the society shall have had an opportunity to be heard in its own defence, and the Commissioner shall make a full report thereof to the Governor in Council.

7. The sum granted by the Legislature and available for general distribution among the societies shall, until otherwise prescribed, be divided upon the following basis, viz :--One half equally among the societies, and the other half pro rata according to the amount of the paid subscription list of each society for the year preceding.

8. The said bonus shall in all cases be subject to such reduction as the Commissioner shall deem it proper to make by way of fine or otherwise, but the decision of the Commissioner in that regard shall be subject to appeal to the Governor in Council.

9. Every society incorporated under the Act shall file with the Secretary for Agriculture, on or before the first day of December in each and every year, an account in detail of its receipts and expenditures during the year then next preceding, in such form as the Commissioner shall prescribe; or in case the society shall have been in operation for less than a year, then such society shall file an account for such part of a year as it has been in operation; and the Secretary for Agriculture on receiving such ac-
