counts shall forthwith proceed to audit the same, and shall report the result of such auditing to the Commissioner, with such recommendations in each case as may seem proper; and the Commissioner shall submit the same to the Governor in Council; and no grant shall be paid by way of bonus to a society without the order of the Governor in Council.

10. A society not filing its accounts on or before the first day of December in any year, shall not be entitled to a grant for the next year unless the Commissioner, on good cause shown for the delay, shall otherwise recommend.

11. In case it shall be made to appear to the satisfaction of the Commissioner, that by reason of the sparse settlement of a district, or for some other good cause, it is not possible to obtain a membership of fifty or a subscription list of one hundred dollars, the Commissioner on application being made to him by petition reciting the facts, may enquire into the same and report thereon to the Governor in Council, with such recommendation as he may think proper, and the Governor in Council may permit the establishment of a society in such district, with a membership of less than fifty, and a subscription list of less than one hundred dollars ; but the Governor in Council may at any time require such society to increase its subscription and membership to the limit provided by the first Section of these Regulations. upon pain of forfeiture of its status under the Agricultural Act of 1888.

12. The societies incorporated under this Act may hold meetings for discussion and for hearing lectures on subjects connected with the theory and practice of Agriculture, improved husbandry and kindred arts; may promote the circulation of agricultural and horticultural periodicals, or periodicals devoted exclusively to stock raising; may import or otherwise procure seeds, plants and animals of new and valuable kinds; but this shall not extend to authorize societies to traffic in ordinary seeds, or to purchase animals already owned in the district in which the society is located; may offer prizes for essays on agriculture, horticulture, dairying, fruit raising, stock raising; may award premiums for excellence in stock, agricultural products, fruits, vegetables, plants and flowers, and generally for excellence in any agricultural or horticultural production or operation.

13 The funds of the societies shall not be used for any purpose inconsistent with these above mentioned.

14. If a society shall propose to hold a show at which prizes are to be awarded, the prize list shall be sent to the Secretary for Agriculture at least two months before the date at which the show is to be held, and the Secretary shall submit the same to the Commissioner, and the Commissioner may, if he deems proper, direct such alterations to be made therein as he believes calculated to promote the interests of agriculture; but if the Commissioner shall not direct any changes to be made in such list within one month after the same has been filed with the Secretary, the list shill be deemed approved.

15. Every society incorporated under the Act may, ou of its corporate funds, appropriate a part to defray the expenses of one or more representatives to the Provincial Farmers Association at its annual session, under such conditions as shall be approved of by the Commissioner.

16. It shall be the duty of the officers of every society to assist the Secretary for Agriculture in the collection of statistical and other information relating to agriculture as he may from time to time require; and the Secretary of every society shall, on or before the first day of December in each year, file with the Secretary for Agriculture a report on agricultural matters within his District, in such form as the Commissioner may prescribe.

17. Every society shall, as soon as may be after receiving its letters patent, adopt a code of bye-laws for its government; but such bye-laws shall not be inconsistent with the Act or any Regulations of the Governor in Council, and shall not go into operation without the sanction of the Commissioner; but the Governor in Council may prescribe certain bye-laws for all the societies.

18. The duties imposed upon the Commissioner by these Regulations may be discharged, and the authority hereby conferred may be exercised by the Secretary for Agriculture, if the Commissioner shall so authorize.

19. Nothing in these Regulations contained shall prevent any person residing in one District from subscribing to and becoming a member of a society in another District. R. W. L. TIBBITS,
