WITNESS, the Honorable Sir WILLIAM JOHNSTON RITCHIE, Knight, Deputy of Our Right Trusty and Well-Beloved the Right Honorable Sir FREDERICK ARTHUR STANLEY, Baron Stanley of Preston, in the County of Lancaster, in the Peerage of the United Kingdom; Knight Grand Cross of Our Most Honorable Order of the Bath; Governor General of Canada.

At Our Government House, in Our CITY of OTTAWA, this SEVENTH day of OCTOBER, in the year of Our Lord one thousand eight hundred and eightynine, and in the Fifty-third year of Our Reign.
