#### PROCLAMATION.

HEREAS in consequence of the union of the Cities of Saint John and Portland, and for other good and No Discount. sufficient reasons appearing, it is deemed desirable to constitute the united City a Health District, and to include therein the remaining portion of the City and County of Saint John, as provided for by Act of Assembly 52nd Victoria, Chapter 8.

It is, therefore, hereby ordered and proclaimed, under and by virtue of the authority contained in the said Act of Assembly, Chapter 8 of 52nd Victoria, that the several Boards of Health for the City of Portland, the City of Saint John, and the remaining portion of the County of the City and County of Saint John respectively, as at present constituted, be dissolved, and the City and City and County of Saint John constituted a Health District in lieu thereof, under "The Public Health Act, 1887," and amending Acts.
