WITNESS, the Honorable Sir WILLIAM JOHNSTON RITCHIE, Knight, Deputy of Our Right Trusty and Well-Beloved the Right Honorable Sir FREDERICK ARTHUR STANLEY, Baron Stanley of Preston, in the County of Lancaster, in the Peerage of the United Kingdom; Knight Grand Cross of Our Most Honorable Order of the Bath; Governor General of Canada.

At Our Government House, in Our CITY of OTTAWA, this SEVENTH day of OCTOBER, in the year of Our Lord one thousand eight hundred and eighty-nine, and in the Fifty-third year of Our Reign.
