PUBLIC NOTICE is hereby given, that under "The New Brunswick Joint Stock Companies' Letters Patent Act " and Brunswick Joint Stock Companies' Letters Patent Act" and Amending Acts, Letters Patent have been issued under the Great Seal of the Province of New Brunswick, bearing date the six-teenth day of June, A. D. 1890, incorporating John F. Zebley, of the City of New York, in the United States of America, Banker: Frank W. Purdy, of the City of Saint John, in the City and County of Saint John, Accountant; for the purpose of constructing. of Saint John, Accountant; for the purpose of constructing, operating and maintaining in the City of Saint John and adjoin-ing districts all customary and proper works for the manufac-ture, distribution and sale of Electricity for all purposes for which the same may be employed, and for the manufacture of merchantable articles by process of Electricity, and for the trading in said manufactured articles; to purchase, or lease, or otherwise acquire any real or personal property, patents of in-vention, easements, franchises or privileges which the Company may think necessary or convenient for the purposes of its busi-ness; to lease, sell, transfer, mortgage or otherwise convey and deal with the real or personal property and patents of inven-tion acquired by the Company, and for such purpose to sign, seal, execute and deliver all necessary conveyances, mortgages and other instruments in writing necessary in the premises, with covenants contained in the same; to purchase, lease or other-wise acquire the whole or any part of the property, franchises of, or to amalgamate or enter into any working agreement with any other Company incorporated for Electric lighting or Electric power purposes, having authority to so contract, with power to enter by its servants and employees from time to time upon any public street, alley or highway in the City of Saint John and adjoining districts, and break up or open the same, or any part thereof, along or across such public streets, alleys or highways, for the purpose of erecting poles and posts, and stringing and erecting electric wires thereon, and for renewing and repairing

such erections, wires or plant subject to certain conditions in the Letters Patent more particularly defined; by the name of "THE EASTERN ELECTRIC COMPANY, (Limited)," with a total capi'al of One hundred and fifty thousand dollars, divided into fifteen thousand shares of Ten dollars each.
