PROCLAMATION.

WHEREAS, by an Act made and passed in the fifty fourth year of the Reign of Her present Majesty's intituled "An Act to amend Chapter 65 of the Consolidated Statutes, of 'Schools,' and Chapter 64 of the Consolidated Statutes, of 'The University of New Brunswick,' it was, amongst other things, enacted that the said Act should not go into operation until the same should be notified by Proclamation by the Lieutenant Governor;

AND WHEBEAS, I have this day determined to issue my Proclamation, in pursuance of the power given me in that behalf in the said Act;

NOW THEREFORE, I do hereby in and by virtue of the said Act of Assembly proclaim and declare, and hereby

CROWN LAND OFFICE, 7th Oct, 1891.
