ANNO QUINQUAGESIMO QUARTO VICTORIÆ REGINÆ

An Act to amend the Highways Act 1886, and Chapter 13 of 53rd Victoria.

Passed 16th April, 1891.

BE it enacted by the Lieutenant Governor, Legislative Council and Assembly, as follows:—

1. Section 26 of the said Highway Act is hereby repealed, and the following enacted in its stead:—

"There shall be annually levied a tax for the general repairs and maintenance of all public roads, streets and bridges in each County, which shall be called the Road Tax, and which shall be assessed as follows:—Upon the poll of every male person, except he be a Clergyman or a Licensed School Teacher, in actual employment as such, between the ages of twenty one and sixty years,
