

NOTICE IS HEREBY GIVEN, That within one month after the last publication of this notice, application will be made to His Honour the Lieutenant-Governor-in-Council, for a Charter of Incorporation by Letters Patent, under the provisions of the Act of the General Assembly, 56 h Victoria, Chapter 7, intituled "The New Brunswick Joint Stock Companies' Act, 1893" and amending Acts, incorporating the applicants and such other persons as may become shareholders in the proposed Company a body corporate and politic, under the name and for the purposes hereinafter mentioned.

1. The proposed name of the Company is the "Scott Lumber Co., Ltd."

2. The objects for which the incorporation of the Company is sought are:—

(a) To carry on and operate a general lumbering and saw milling business in all its branches including the logging, driving, sawing, manufacturing and shipping of logs, lumber, bark, wood and wood products of every nature kind or description, and the buying, selling and dealing in logs, lumber, bark, wood and wood products, manufactured and unmanufactured, both wholesale and retail, and for that purpose to construct, purchase, acquire, lease, maintain, hold and enjoy and otherwise possess in fee simple, lands, tenements and hereditaments, grants, licenses and lumber lands, and limits, lumber rights, options, mills, mill privileges, milling business stores, warehouses, machine shops, blacksmith shops, water ways and rights, buildings, plant, machinery, tramways, wharves, booms, piers, dams, driving rights, franchises, patents of invention and privileges, and such other real and personal property as may from time to time be acquired or deemed necessary for all or any of the purposes of or incidental to the business aforesaid, in the Province of New Brunswick or elsewhere in the Dominion of Canada.

(b) To construct, purchase, lease, hire, operate and maintain, make or manufacture or otherwise acquire, and to own, hold, let, operate and control in the course, and for the purposes of the Company or anything incidental thereto, saw mills, machine shops, blacksmith shops, repair shops, houses, boarding houses, booms, piers, dams, wharves, boats, barges, scows, tug-boats, vessels, steamers, machinery, implements, erections, crafts, plant, goods, chattels, and effects necessary or convenient for, or incidental to any or all the purposes of the Company.

(c) To purchase, hire, acquire, build, own, charter, navigate, and maintain steamers, sailing vessels and other craft, including tugs, scows, barges and all equipment therefor for the carrying and conveyance of lumber, goods, chattels and freights, and the towing, hauling, transporting, rafting and booming of timber upon the waters of the River Saint John, its tributaries, as well as the Magaguadavic waters, both in Province aforesaid, and the waters adjacent to either, and any other waters, and to operate, prosecute and carry on the business of common carriers of lumber and goods as may be necessary or incidental to any of the purposes of said Company.

(d) To carry on the business of buying, selling, trading, bartering and dealing in all kinds of goods, wares and merchandise, including farm products, both wholesale and retail, and for that purpose to purchase, lease, or otherwise acquire, hold and enjoy lands, buildings, stores, factories, warehouses and plant considered necessary, desirable or expedient by the Company.

(e) To acquire by purchase, subscription or otherwise, and to hold, sell, mortgage or otherwise dispose of shares and stock, either common or preferred, or bonds, debentures, stock or other interest in any Company having objects altogether or in part similar to those of the Company, and to acquire and undertake the whole or any part of the business, property and liabilities of any person or Company carrying on business which this Company is authorized to carry on, or possessed of property suitable for the purposes of this Company, with power to amalgamate with any such Company.

(f) To purchase, lease, exchange, hire or acquire any real or personal property, patents, patent rights, licenses, franchises and privileges for the purposes herein set forth, with full power and liberty at any and all times to sell mortgage, lease, or otherwise dispose of the operations or undertakings of the Company, or any part thereof, or of any or all of the property, franchises, assets, rights or credits of the Company, for such consideration as the Company may deem fit.

(g) To do any and all things above set forth as objects, purposes, powers or otherwise, and any and all things necessary or incidental thereto for the accomplishment of the purposes or the attainment of the objects or the exercise of the powers hereinbefore enumerated, or any of them, and as well without the Province of New Brunswick as within to the same extent and as fully as natural persons might do.

3. The head office or chief place of business is to be at the Parish of Dumfries, in the County of York.

4. The amount of the capital stock of the Company is to be Ninety-eight thousand dollars, divided into nine hundred and eighty shares of One hundred dollars each.

5. The names in full, addresses and callings of the applicants, of whom the first three shall be Provisional Directors, are as follows: James M. Scott, Parish of Dumfries, in the
