Certain amendments having been omitted in the Game Act as published in last week's issue of Royal Gazette, it is now published as amended.

CAP. XLIII.

An Act respecting the protection of Game.

Passed 9th May, 1903.

Be it enacted by the Lieutenant Governor and Legislative

Assembly as follows:—
Notwithstanding anything contained in Chapter 189 of the Act passed during the present Session to revise and consoidate the general public statutes of New Brunswick, Chapter 33 of said Act shall come into force immediately upon the passing of this Act, and be and continue in force until the coming into force of the Consolidated Statutes, 1903. Assembly as follows:-

(Consolidated Statutes, 1903)

CAP. XXXIII. RESPECTING THE PROTECTION OF GAME.

SHORT TITLE.

1. This Chap'er may be cited for all purposes as "The Game Act." 62 V. c. 8, s. 1.

INTERPRETATION.

2. In this Chapter the following expressions have the meaning assigned to them in this section, unless the context

(1) The expression "close season," with reference to each class of game respectively, means the period during which, under the provisions of this Chapter, it is declared to be an offence to do any stated act with reference to such class of game; and the expression "open season," with reference to each class of game respectively, means the period elapsing between any two successive close seasons for such class of game. otherwise requires :-

(2) The expression "game" includes any animal or bird mentioned in this Chapter, or of a species or class similar

ing, pursuing, worrying, following after or on the trait of, or any searching for, shooting at, statking, or lying in wait for any game, whether such game be then or subsequently captured, killed, injured, or otherwise.

(4) The expression "takes" means and includes any capturing or taking into one's possession any game whether alive or dead. (3) The expression "hunts" means and includes any chas-

(5) "Possession" If there be two or more persons, any one of whom, with the knowledge and consent of the rest, has anything in his custody or possession, it shall be deemed and taken to be in the custody and possession of each and all

of them.

(6) The expression "penalty" with reference to an offence under this Chapter includes any fine to which the offender may be liable under this Chapter, and also any imprisonment which, under the provisions hereof, may be imposed in default of the payment or satisfaction of such fine.

(7) The expression "warden" includes the chief game commissioner, a deputy warden, special warden, game guardian, clerk of a market, and every other person temporarily called upon or instructed by a warden to assist in the enforcement of this Chapter.

(8) The expression "justice" includes any justice of the peace, parish court commissioner, stipendary, police or sitting magistrate, appointed or acting in or for any city, county, town, parish or district within the Province.

(9) The expression "constable" includes any sheriff, deputy sheriff, police officer, constable, bailiff, keeper of a gaol or springer, or other person employed, or deputized for the present prison, or other person employed, or deputized for the preservation of the public peace, or for the service or execution of civil process within the Province, and also any warden under

(10) The expression "non-resident" means a person not resident or domiciled within the Province. 62 V. c. 8, s. 2.

OFFERCES IN CLOSE SEASON AND CLOSED DISTRICTS.

3. Every one is guilty of an offence and liable to the pena'ty hereinafter provided, who, between the dates hereinafter in each case specified, exclusive of each date named in any part (unless otherwise provided) of this Province:

(1) Hunts, takes, hurts, injures, traps, snares, shoots, wounds kills or destroys.

Any shore or other birds, on, or along the beaches, islands, or lagoons, bordering the tidal waters of the counties along Northumberland Strait, the Gulf of Saint Lawrence, and the Bay of Chaleur, between the 31st day of December and the 1st day of September in any year. 63 V. c. 39, s 3 (2).

Any wild black duck, wood duck, teal duck, or other kind of wild duck, or any snipe, wild goose, or other wild fowl after sunset and before sunrise, any time between the 1st day of August and the 1st day of December in any year, in or upon those certain marsh lands in the Parish of Shediac, in the County of Westmorland, bounded easterly by a road leading northerly from the main road to the shore between the lands of Gregoire Boudreau and lands of Joseph Leger; southerly by the line dividing the said marshes from the up and; westerly by a road leading northerly from the main road to the sea shore, between the lands of Dominique Boulreau and lands of Zedel Boudreau; and northerly to a high ridge or bank of sand which separates the said marshes from the sea shore, known and northerly to a high ridge or bank of sand which separates the said marshes from the sea shore, known as Boudreau marshes, and the Barachois; or in or upon any of the creeks or ponds thereon. 2 Edw. (2) Has in one's possession, during the close season for hunting beaver, the undressed skin, or any part of the carcase, of any beaver killed in this Province during such close season. 62 V. c. 8, s. 3 (b), am.

(3) Buys or sells, or offers, or exposes for sale (except as otherwise provided in sections 8 and 48),

(4) Wilfully refuses to furnish information, wilfully furnishes fa'se information to a warden or constable, respecting the existence of, or the place of concealment or storage of any game or the carcaes or any portion thereof, or the green hide or pelt of such game. 62 V. c. 8, s. 3 (d).

OFFENCES AT ALL SEASONS.

4. Everyone is guilty of an offence and liable to the penalty hereinafter provided, who, at any time or season hereafter, in any part of the Province (62 V. c. 8, s. 4):—

(1) Hunte, takes, hurts, injures, traps, snares, shoots, wounds, kills or destroys.
