## Education of Deaf and Deaf-Mute Persons.

THE parents and guardians of Deaf and Deat-Mute children in

THE parents and guardians of Deaf and Deat-Mute children in the Province of New Brunswick, are hereby notified that the Board of Education has made arrangements with the Board of Directors of the Institution for the Deaf and Dumb at Halifax, Nova Scotia, for the admission to said Institution of Deaf and Deaf-Mute pupils from New Brunswick. Pupils of the Deaf and Dumb Institution at Fredericton, who on the 30th June, 1902, had not completed at that Institution the full term of years' attendance which they were entitled by statute, will be admitted to the Halifax School for the completion of their course, on the presentation of a certificate signed by the Chief Superintendent of Education of the Province of New Brunswick.

Application on behalf of any other Deaf or Deaf-Mute person for whom admission is desired to the Halifax School, must be made to the Warden of the Municipality; or the Mayor of the City, within which such Deaf or Deaf-Mute person has a settlement under the provisions of Chapter 179 of the Consolidated Statutes, 1903, for an order for the admission of such person into the Institution for the Deaf and Dumb at Halifax. On receipt of such application the said Warden or Mayor, on being satisfied that such Deaf or Deaf-Mute person is between the ages of six and twenty years, and has a legal settlement in the Municipality or City, and forward the same to the Provincial Secretary for his approval to be endorsed thereon. forward the same to the Provincial Secretary for his approval to be endorsed thereon.

The parents, guardians or other friends of Deaf and Deaf-Mute are requested to communicate with the Chief Superintendent of Education. Fredericton, or Mr. James Fearon, Principal of the Institution for the Deaf and Dumb, Halifax, who will give all Institution for the Deal assistance.
