Education of Deaf and Deaf-Mute Persons.

THE parents and guardians of Deaf and Deat-Mute children in the Province of New Brunswick, are hereby notified that the Board of Education has made arrangements with the Board of Directors of the Institution for the Deaf and Dumb at Halifax, Nova Scotia, for the admission to said Institution of Deaf and Deaf-Mute pupils from New Brunswick. Pupils of the Deaf and Dumb Institution at Fredericton, who on the 30th June, 1902, had not completed at that Institution the full term of years' attendance which they were entitled by statute, will be admitted to the Halifax School for the completion of their course, on the presentation of a certificate signed by the Chief Superintendent presentation of a certificate signed by the Chief Superintendent of Education of the Province of New Brunswick.
