

HIGH SCHOOL ENTRANCE EXAMINATION MEDALS.

His Honour the Lieutenant-Governor has been pleased to offer Thirteen Silver Medals to be competed for by the pupils of the Eighth Grade at the High School Entrance Examinations in June next, and thereafter annually during his term of office. The examinations will be held in accordance with the pro-visions of Regulation 46 at the several Grammar Schools, and at such of the Superior Schools as shall make application to the Chief Superintendent not later than the First day of June.
