Given under my Hand and Seal at Fredericton, the fifth day of February, in the year of our Lord one thousand nine hundred and three, and in the third year of His Majesty's Reign.

PROCLAMATION.

WHEREAS, Joseph A. McQueen, Esquire, High Sheriff of the County of Westmorland, has made return to the Honourable the Provincial Secretary, setting forth that an election of the ratepayers of the Town of Sackville in the said County of Westmorland, was held at Sackville aforesaid on the twelfth day of January last, to determine whether the inhabitants thereof should become incorporated under the provisions of the Towns Incorporation Act of 1896.

That at such election there were 304 votes cast; 167 of the ballots being marked "For", and 137 of the ballots marked "Against".

That the boundaries of the said Town are as follows; "Beginning at a marked post standing on the Northwesterly side of the main road leading through Sackville, and on the Easterly angle of Isaac Trueman's homestead lot; thence running North fifty degrees thirty minutes West 2200 feet; thence about South thirty-seven degrees fifteen minutes West to the Westerly angle of Charles Pickard's Homestead farm lot; thence along the Southwesterly line of the said farm lot, in a Southeasterly direction to the Westerly angle of C. Pickard & Co. Quarry Lot; thence South twenty-three degrees, forty-five minutes West, crossing the Lower Fairfield road at a point 385 feet Northwesterly from the Northwesterly side of the Main Road leading from Sackville to Westcock; and extending 346 feet Southwesterly from Southwesterly side of said Fairfield road; thence South ninety-five degrees and twenty minutes East, crossing the main road leading from Sackville to Westcock at the Westerly angle of Control Indianal Paragraphy of South ninety-five degrees and twenty minutes East, crossing the main road leading from Sackville to Westcock at the Westerly angle of Captain John A. Bowser's Homestead Lot; and continuing in a straight line to the Northwesterly angle of the dyke extending along the Easterly side of marsh lands of Rufus Bulmer, thence following the centre of said dyke in a Southerly direction to the Southwesterly line of the said Marsh Lot; thence running South forty-five degrees East to the Tantramar River; thence following the said river upstream to the centre of a small creek 550 feet Easterly from the Easterly side of the Public Wharf; thence North thirty-five degrees East to the edge of the upland; thence along the edge of the upland in an Easterly direction to its intersection with the Southwesterly side of the road leading to the Dixon body of Marsh; thence North forty-seven degrees thirty minutes East, striking the Intercolonial Railway at a point 350 feet Easterly from the easterly side of the Landing Road (so called), thence following the Intercolonial Railway in an Easterly direction to the Tantramar River, thence following the said

river up stream to the centre of Robinson's Creek; thence up said Creek in a Northerly direction to the Aboideau; thence North one degree thirty minutes West to the Easterly angle of the Exhibition grounds, thence along the edge of the upland in an irregular Northwesterly direction to the point where the Northwesterly line of W. C. Miller's Homestead lot meets the edge of the marsh; thence North forty-six degrees East, crossing the back road (so called) at a point 210 feet Southeasterly from the Southeasterly side of Squire Street, and extending in a straight line 330 feet Northeasterly from the Northeasterly side of the said road; thence North fifty-three degrees forty-five minutes West to the place of beginning."

And it appearing by said Return that a majority of the ratepayers of said Town have voted in favor of Incorporation;

I do therefore proclaim that the said Town of Sackville, comprised within the boundaries hereinbefore described, be incorporated under and by virtue of the provisions of the Towns Incorporation Act.
