#### UNDER "THE LIQUOR LICENSE ACT, 1896."

NOTICE IS HEREBY GIVEN, That the Liquor License Commis-sioners for the License District of Restigouche County, under "The Liquor License Act, 1896," will meet at the Court House in the Town of Dalhousie, on THURSDAY the 21st day of APRIL instant, at ten o'clock in the forenoon, to consider applications for license to sell liquor under the provisions of the said Act in the said license district, for the year commencing the first day of May next, and any other matter relating thereto that may come before them.

The total number of licenses in this district at present is six—all retail; three of which are in the Parish of Dalhousie, the licensees being Thomas Murphy, Henry Wipper and Leon Samson; and three in the Parish of Durham, the licensees being Michael P.
