

NOTICE IS HEREBY GIVEN, That the parties hereinafter named will apply to His Honor the Lieutenant-Governor-in-Council for a grant of a charter of incorporation, by Letters Patent, under the Great Seal of the Province of New Brunswick, according to the provisions of "The New Brunswick Joint Stock Companies Act", incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes hereinafter set forth.

1. The proposed name of the Company is "R. C. ELKIN, (Limited)."

2. The objects and purposes for which incorporation is sought are:—

(a) To purchase or otherwise acquire, buy, sell, hire, construct, charter, trade in, manage, own, operate and control vessels, tug-boats, steamers and other craft, and any interests and shares therein and generally to carry on the business of ship broker, ships husband, ship agent, ship chandler and shipping merchant, and other like businesses.

(b) To conduct and carry on a general shipping and forwarding business, the receiving, handling, shipping, forwarding and transporting by water or otherwise, of goods, wares and merchandise and all classes of freight.

(c) To acquire by original subscription, purchase or otherwise and to own, hold, manage, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock and bonds, debentures or other evidences of indebtedness created by any other company or companies, and while the holder thereof to exercise all the rights and privileges of ownership including the right to vote thereon.

(d) To sell, lease, mortgage, pledge or otherwise dispose of or encumber the undertaking of the Company, or any part thereof, or all or any real or personal property or other assets of the Company for such consideration, and upon such terms, and in such manner as the Company may deem desirable.

(e) Generally to purchase, take on lease or in exchange, hire, or otherwise acquire any real and personal property and any rights or privileges which the Company may think necessary or convenient for the purposes of its business.

(f) To acquire the good-will, rights, property and assets of all kinds and to undertake the whole or any part of the liabilities of any person, firm, association or corporation having like or similar objects, and to pay for the same wholly or in part in cash, stock, bonds, debentures or other securities of this Company or otherwise.

(g) To act as general brokers, agents and adjusters in all lines of insurance.

(h) To carry on any other business which may seem to the Company capable of being conveniently carried on in connection with the above lines of business or any of them, or calculated directly or indirectly to enhance the value of the Company's property or rights.

(i) To do all and everything necessary, suitable, convenient or proper for the accomplishment of any of the purposes, or the attainment of any one or more of the objects herein enumerated or incidental to the powers herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation either as holders of, or as interested in any property or otherwise to the same extent and as fully as natural persons might or could do, and as well without as within the said Province.

3 The office or principal place of business is to be in Fairville, in the City and County of Saint John and province of New Brunswick.

4 The capital stock of the Company is to be Twenty thousand dollars, divided into two hundred shares of One hundred dollars each.
