GOVERNMENT NOTICE. His Honour the Lieutenant-Governor has been pleased to ap-prove of the following Regulation :--"It shall be unlawful for any person or persons to dig clams on the foreshore, bring the land between high and low water mark, of the County of Charlotte, in the Province of New Brunswick, and any person digging clams upon such foreshores without a license, to be issued by the Surveyor General, or without the authority of the licensee under any such license, shall be hable to a penalty of not more than ONE HUNDRED DOLLARS and not less than TEN DOLLARS, which penalty may be recovered under the provisions of the Summary Convictions' Act, by any person prosecuting for the same."

#### SAMPLES OF CHOICE GRA MENT OF SEED.

BY INSTRUCTION of the Hon. Minister of Agriculture another distribution will be made this season of samples of the most pro-ductive sorts of grain to Canadian farmers for the improvement of seed. The stock for distribution is of the very best and has been secured mainly from the excellent crops recently had at the branch Experimental Farm at Indian Head in the North-west Territories. The distribution this spring will consist of samples of oats, spring wheat, barley, Indian corn and potatoes. The quantities of oats, wheat and barley to be sent this year will be 4 lbs. of oats and 5 lbs. of wheat or barley, sufficient to sow one twentieth of an acre. The samples of Indian corn and pota-toes will weigh 3 lbs. as heretofore. Every farmer may apply, but only one sample can be sent to each applicant, hence if an individual receives a sample of oats he cannot also receive one of wheat, barley or potatoes, and applications for more than one BY INSTRUCTION of the Hon.
