The upset price for mileage on Timber Licenses will be Twenty Dollars per square mile, and the renewal mileage on Timber Licenses will be Eight Dollars per square mile.

To erect and maintain the necessary posts, poles, wires and other works along the public streets and highways, between, throughout and within the towns and parishes in the territory above specified, and for that purpose to have full power and authority for the said Company, its successors or assigns, its or their agents and workmen to enter upon the side or sides of all or any of the roads, bridges, streets or highways, and upon the same to set up, erect and construct such and so many posts, poles or other works as the Company in its discretion may deem necessary for making, completing, supporting, using, working and maintaining a system of communication by telephone between, throughout or within the said places or within the said territory.
