D. 1904; incorporating Frederick W. Andrews, of the Town of Saint Stephen, in the County of Charlotte and Province of New Brunswick, Gentleman; J. Edwin Ganong, of the same place, Manufacturer; Lewis F. Mills, of the same place, Accountant; Arthur D. Ganong, of the same place, Superintendent; and N. Mark Mills, of the same place, Barrister-at-Law; for the following purposes, namely:—

To establish, maintain, operate, conduct and carry on a general telephone business in all its branches, including the building of offices, the setting up, erecting and constructing of poles and posts, stringing or putting up of wires, making of connections, buying, selling and leasing of telephone instruments, wires and all other fittings, appliances and apparatus used and employed in carrying on a telephone business, and generally to do all and everything necessary to complete, support, use, work and maintain a system of telephonic communication between and throughout the towns and parishes in the County of Charlotte; also to make connection with any other telephone company, or to lease the system of or amalgamate, or to lease to any other telephone company. To purchase, lease or otherwise acquire, own and hold such lands, licenses, privileges, buildings, plant and other real and personal property as may be required for the above purposes. To erect and maintain the necessary posts, poles, wires and other works along the public streets and highways, between, throughout and within the towns and parishes in the territory above specified, and for that purpose to have full power and authority for the said Company, its successors or assigns, its or their agents and workmen to enter upon the side or sides of all or any of the roads, bridges, streets or highways, and upon the same to set up, erect and construct such and so many posts, poles and other works as the Company in its discretion may deem necessary for making, completing, supporting, using, working and maintaining a system of communication by telephone between, throughout or within the said places or within the said territory. To stretch wires thereon, and from time to time as often as may be necessary to break open any part of the said roads, streets or highways, not, however, to interfere with that part of the same appropriated for the use of carriages, sleighs, sleds, wagons or other vehicles or horses, and to keep the same open during the time necessary for the setting up, erecting, constructing, maintaining and repairing or replacing all such posts, or other works used in connection with the works of the said proposed Company. Provided, however, that the said Company shall place such roads, streets and highways in as good a condition as the same were before they opened up the same, and shall make such repairs without unnecessary delay, and on failure of the said Company to do so, the Supervisor or Commissioner of roads may repair the same at the expense of the said Company. And also provided, that nothing herein contained shall authorize the said Company to in any way interfere with or impair the efficiency of any telegraph or telephone company now in operation, nor shall the Company be authorized to place any pole or post opposite the door or window of any house, store or other building, or opposite the entrance to any lot of land, farm or premises; by the name of "THE CHARLOTTE COUNTY TELEPHONE COMPANY, Limited"; with a total Capital Stock of Seven thousand five hundred dollars, divided into seven hundred and fifty shares of Ten dollars each.
