IN THE MATIER OF THE NEW BRUNSWICK JOINT STOCK COMPANIES' ACT.

NOTICE IS HEREBY GIVEN, That application will be made by the parties hereinafter named, to His Honor the Lieutenant-Governor-in-Council, for the granting of Letters Patent, under the Great Seal of the Province of New Brunswick, under the provisions of the New Brunswick Joint Stock Companies' Act, incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes hereinafter set forth.

1. The proposed name of the Company is "Moncton Pasteurized Milk Company, Limited."

2. The objects for which incorporation is sought are:

(a) To purchase, acquire and take over certain lands and plant for the pasteurizing and sale of milk and cream at Lewisville, in the Parish of Moncton, in the County of Westmorland and Province of New Brunswick.

vince of New Brunswick. (b) To acquire the good-will of any business within the objects

of the Company, in any lands, tenements and hereditaments, privileges, contracts, rights, powers appertaining to the same.

(c) To sell and dispose of the whole, or any part of the property or undertaking of the proposed Company, to any other Company

or person.

(d) To manufacture, produce, sell and otherwise deal in condensed, preserved, pasteurized and evaporated milk and cream, and all other forms of milk and the products thereof.

(e) To purchase, produce, manufacture, purify, prepare and otherwise deal with, either by retail or wholesale, fresh milk, butter and cheese, and all other products of milk, and to do any or all things connected with or incidental to the carrying on of such business or any branch or part thereof. business, or any branch or part thereof.
