RE EXTRA PROVINCIAL CORPORATIONS.

NOTICE IS HEREBY GIVEN, That by Act of the Legislature of the Province of New Brunswick, passed on the 9th day of May. A. D. 1903, intituled "An Act respecting the Licensing of Extra Provincial Corporations," provision is made that Companies incorporated without the Province, in respect to which no license fee is now payable under same other Provincial Statute, shall pay a license fee for doing business within the Province and shall also pay an annual license fee thereafter. The fee payable, where the capital stock does not exceed \$100,000, is \$50; where it exceeds \$100,000, \$100.
