PROCLAMATION.

WHEREAS, Timothy Robinson, High Sheriff of the County of Restigouche, has made a return to the Honourable the Provincial Secretary, setting forth that an election of the rate-

payers of the Town of Dalhousie, in the said County of Restigouche, was held at the Town of Dalhousie aforesaid on the twelfth day of September last, to determine whether the inhabitants thereof should become incorporated under the provisions of Chapter 166 of the Consolidated Statutes, 1903, intituled "The Towns Incorporation Act."

That at such election there were 98 votes cast; 92 of the ballots being marked "For," and 6 of the ballots being marked "Against."

That the boundaries of the said Town are as follows:—"All that part of the Parish of Dalhousie, in the County of Restigouche, bounded as follows: On the North by the northern boundary line of the County of Restigouche, on the East by the river Restigouche and Bay Chaleur, on the South by the south line of a lot of land owned and occupied by John Barberie, thence following the south line Westerly to the west line of said lot, thence in a direct line to the north line of a lot of land granted to Pascal Charlefort, thence following the said north line of the said Pascal Charlefort lot West to the easterly line of a lot of land owned and occupied by Alexander Cook, and on the West by the east line of the Alexander Cook lot."
