PRO LAMATION.

WHEREAS, Levite A. Gagnon, High Sheriff of the County of Madawaska, has made return to the Honourable the Provincial Secretary, setting forth that an election of the ratepayers of the Town of Edmundston, in the said County of Madawaska, was held at the Town of Edmundston aforesaid, on the thirty-first day of January last, to determine whether the inhabitants thereof should become incorporated under the provisions of The Towns Incorporation Act and amendments thereto.

That at such election there were 254 votes cast: 141 of the bal-

That at such election there were 254 votes cast; 141 of the ballots being marked "For," and 111 of the ballots being marked "Against," and two ballots being rejected.

That the boundaries of the said Town are as follows:—" Begin-

ning at the point where the upper or western boundary line of lot number two in the Parish of Madawaska, north of the Saint John River, granted to Michael Tighe, strikes the said river, thence in northeasterly direction along the said upper or western boundary of the said lot number two to the Madawaska river, thence following the course of the said Madawaska river in a southerly direction down stream to the upper or northerly boundary of lot number two in the Parish of Madawaska east of the Madawaska river, granted to Joseph Martin, Junior, now owned and occupied by Florent Martin, Florent Fournier, Joseph Martin (Monoc), Joseph Martin a Makime and Joseph O. Levesque, the product of the said partiage of said lot number the tin (Monoc), Joseph Martin a Makime and Joseph O. Levesque, thence along the said northern boundary of said lot number two, in an easterly direction, to the rear of the first tier of lots east of the Madawaska river, thence in a southerly direction along the base line of the said first tier of lots to the western or upper boundary line of lot two hundred and five granted to Paul Cyr, thence along the said side line in a southeasterly direction to the most north-western angle of lot number one, in the Parish of Saint Basil, granted to John Hartt, thence following the rear line of said lot number one in an easterly direction to the western or upper boundary line of the Indian Reserve Land, in the Parish of Saint Basil, thence along the same in a southwesterly direction to the Basil, thence along the same in a southwesterly direction to the Saint John river, thence following the course of the said river up stream in a westerly direction to the place of beginning, including within the boundaries of the said Town the Town Plat of Edmundston, so called, lots numbers one and two north of the Saint John river in the Parish of Madawa-ka, lots number one, two, and the lots of land granted to Simon Hebert, James Murchie and Florent Hebert east of the Madawaska river and north of the Saint John river, and the Ordinance land in the Parish of Madawaska, and lot number one north of the Saint John river, in the Parish of Saint Basil, granted to John Hartt."

And it appearing by the said return that a majority of the rate-payers of the said town have voted in favor of incorporation:

I do therefore proclaim that the said Town of Edmundston, comprising within the bounds hereinbefore described, be incor-

porated under and by virtue of the provisions of the Towns Incorporation Act and Acts in amendment thereto.
