The Professor will be elected in the first instance for a period of seven years, and will be entitled during that period to the annual income of £900, arising out of the annual income of Mr. Beit's foundation. If after the expiration of six years the Hebdomadal Council shall, after consultation with the Electoral Board, decide that the continuance of the Professorship will be of advantage to the University, the endowment will be made permanent, and the Professor will be entitled to the like annual income of £900 payable from this permanent endowment.

It will be the duty of the Professor to lecture and give instruction on the history of the British Dominions and possessions over the Seas, exclusive of India and its dependencies, but including the history of the American Colonies before their separation from the

He will be subject in respect of residence and duties to the General Regulations laid down in Statt. Tit. IV. Sect. I. § 3, (Oxford University Statutes, p. 55, ed. 1904), and also to the Particular Regulations applicable to the Professors enumerated in Schedule A, (ibid., p. 60). He must, in addition to his ordinary lectures, deliver at least once annually, after previous public notice, a public lecture open to all members of the University without payment of any fee.
