

NOTICE IS HEREBY GIVEN, That application will be made by the applicants herein after named to His Honour the Lieutenant-Governor-in-Council, for a grant of Letters Patent of Incorporation, under the Great Seal of the Province of New Brunswick, under the provisions of "The New Brunswick Joint Stock Companies' Act," Chapter 85, Consolidated Statutes, 1903, and amending Acts, incorporating and constituting the applicants and such other persons as may become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes hereinafter mentioned:

1. The proposed corporate name of the Company is to be "THE SACKVILLE WOOD-WORKERS, Limited."

2. The objects for which incorporation is sought are:

(A) To purchase or otherwise acquire, take over and carry on the business now carried on and engaged in by Charles A. Milton, of the Town of Sackville, in the County of Westmorland, and which business consists principally in manufacturing, buying, selling and dealing in lumber, building and other materials for building and other purposes, the contracting for and the construction and erection of all classes of buildings, and without limitation or restriction, all other undertakings in construction work, and the carrying on of a wood-working factory in connection with the said business.

(B) To establish, carry on and conduct, in whole or in part, all and singular a business of the like nature, kind and description as aforesaid, and as comprehensive as above described, and to establish, carry on and conduct a business in the manufacture and sale of all classes of furniture, desks, tables, chairs and office fittings and fixtures, and without restriction or limitation by the foregoing, any and all other articles, machines, implements and goods of every nature, kind and description made of wood or metal, or of wood and metal combined, or of any other material other than wood or metal, and also the purchasing, selling and trading in all the above goods, products, materials and articles, and when deemed advisable from time to time to purchase or otherwise acquire, in whole or in part, any business of a like or similar description to the aforesaid business.

(C) To take, hold, purchase or otherwise acquire from time to time lands and premises, wharves, railway and shipping facilities for the purposes of the business and undertaking of the Company, and to sell, convey, encumber, lease, let or otherwise part with all and singular any or all of such lands, wharves, railway and shipping facilities.

(D) To sell, lease, mortgage, pledge or otherwise dispose of the undertaking of the Company or any part thereof, or the goods, chattels, rights and credits of the Company, to amalgamate with any other company, to purchase, procure or otherwise acquire the business of any company or person doing a business within the objects of the Company.

(E) To do all such other things as are incidental to or necessary in the carrying on of the said business and undertaking of the Company.
