

REGULATIONS.

IT IS ORDERED and declared that the following Regulations, to be observed and executed by health officers of the Provincial and Local Boards of Health hereafter specified, and by all other persons within the Province, be made, and the same are hereby made and declared:—

REGULATION 1. That from and after the date hereof, and until this Regulation is repealed, all persons found or being within the Town of Campbellton, in the County of Restigouche, shall be vaccinated, except any person who shall satisfy the health officer or officers upon whom is imposed the duty of such vaccination, that he or she has already been vaccinated within a period so recent that a re-vaccination is not necessary or expedient, and except in the case of any such person where such officer may deem that vaccination would be injudicious owing to the then state of health of such person, or for other like good and sufficient reason. It shall be the duty of the Local Board of Health of the Town of Campbellton to forthwith appoint or designate one or more, and so many officers as may be necessary, whose duty it shall be to perform such vaccination, free of charge to the persons vaccinated, in said Town. It shall be the duty of every person found or being within said Town of Campbellton during the period within which this Regulation is in force, upon being notified or required by an officer of the said Local Board so to do, to forthwith attend at the office of the said Local Board of Health of the Town of Campbellton, or at such other place in the said Town of Campbellton and within such hours as the Local Board of Health may fix and determine, and to be vaccinated, unless the officer, after examination, declares such vaccination unnecessary or inexpedient. The cost of such vaccination shall be borne and paid by the said Town of Campbellton. The charges for the said work shall be first approved of by the Local Board of Health, and afterwards submitted for approval to the Lieutenant-Governor in Council, and such portion thereof as the Lieutenant-Governor in Council may hereafter determine may be reimbursed to the said Town. It shall be the duty of every parent or guardian having the charge or custody of any minor under the age of sixteen years, within said Town, upon being notified or requested to have such minor vaccinated, to forthwith bring such minor to the office or place designated by the Local Board of Health, and to have such minor then and there vaccinated, unless the officer shall declare such vaccination unnecessary or inexpedient, and any request or notice requiring such minor to be vaccinated, or to so attend as aforesaid to be vaccinated, may be made of and directed to such parent or guardian instead of to such minor in person. In case of the neglect or refusal of any person to attend and submit to vaccination in accordance with this regulation, or of any parent or guardian responsible for the attendance of any minor as aforesaid to have such minor attend and submit to such vaccination as aforesaid, the Chairman of the Local Board of Health for the said Town of Campbellton shall and may exercise all the powers and authority in such case in him vested under and by the Public Health Act, 1898, and all officers appointed or designated by the Local Board of Health, or whose duty it shall be to assist and aid in the carrying out of this Regulation shall, for such purpose have all the powers, rights and authorities by said Act given and provided, and all persons disobeying or violating the provisions of this Regulation shall be subject to the penalties by said Act provided.

REGULATION 2. That from and after the date hereof, and until this regulation is repealed, all persons found or being within the City of Moncton, in the County of Westmorland, shall be vaccinated, except any person who shall satisfy the health officer, or officers upon whom is imposed the duty of such vaccination, that he or she has already been vaccinated within a period so recent that re vaccination is not necessary or expedient, and except in the case of any such person where such officer may deem that vaccination would be injudicious, owing to the then state of health of such person, or for other like good and sufficient reason. It shall be the duty of the Local Board of Health of the City of Moncton to forthwith appoint or designate one or more and so many officers as may be necessary, whose duty it shall be to perform such vaccination, free of charge to the persons vaccinated in said City. It shall be the duty of every person found or being within said City of Moncton during the period within which this regulation is in force, upon being notified or requested by an officer of the said Local Board so to do, to forthwith attend at the office of the said Local Board of Health of the City of Moncton, or at such other place in said City of Moncton and within such hours as the Local Board of Health may fix and determine, and to be vaccinated, unless the officer, after examination, declares such vaccination unnecessary or inexpedient. The cost of such vaccination shall be borne and paid by the said City of Moncton. The charges for the said work shall be first approved of by the Local Board of Health, and afterwards submitted for approval to the Lieutenant-Governor in Council and such portion thereof as the Lieutenant-Governor in Council may hereafter determine may be reimbursed to the said City. It shall be the duty of every parent or guardian having the charge or custody of any minor under the age of sixteen years, within said City, upon being notified or requested to have such minor vaccinated, to forthwith bring such minor to the office or place designated by the Local Board of Health, and to have such minor then and there vaccinated, unless the officer shall declare such vaccination unnecessary or inexpedient, and any request or notice requiring such minor to be vaccinated, or to so attend as aforesaid to be vaccinated, may be made of and directed to such parent or guardian instead of to such minor in person. In case of the neglect or refusal of any person to attend and submit to vaccination in accordance with this regulation, or of any parent or guardian responsible for the attendance of any minor aforesaid, to have such minor attend and submit to such vaccination as aforesaid, the Chairman of the Local Board of Health for the said City of Moncton shall and may exercise all the powers and authority in such case in him vested under and by virtue of the Public Health Act, 1898, and all officers appointed or designated

by the Local Board of Health, or whose duty it shall be to assist and aid in the carrying out of this regulation, shall for such purpose have all the powers, rights and authorities by said Act given and provided, and all persons disobeying or violating the provision of this regulation shall be subject to the penalties by said Act provided.

REGULATION 3. Whenever within any health district, within the Province of New Brunswick it shall be found by the Local Board of Health for such district that a case of smallpox exists, in case such district be a City or Town, the following regulation shall at once come into force and effect in such district: That from and after the date hereof, and until this regulation is repealed, all persons found or being within the said district, shall be vaccinated, except any person who shall satisfy the health officer or officers upon whom is imposed the duty of such vaccination that he or she has already been vaccinated within a period so recent that a revaccination is not necessary or expedient, and except in the case of any such person where such officer may deem that vaccination would be injudicious, owing to the then state of health of such person, or for other like good and sufficient reason. It shall be the duty of the Local Board of Health for the said district to forthwith appoint or designate one or more and so many officers as may be necessary, whose duty it shall be to perform such vaccination, free of charge to the persons vaccinated, in said district. It shall be the duty of every person found or being within the said district within the period during which this regulation is in force, upon being notified or required by an officer of the said Local Board so to do, to forthwith attend at the office of the said Local Board of Health of the said district, or at such other place in said district and within such hours as the Local Board of Health may fix and determine, and to be vaccinated, unless the officer, after examination, declares such vaccination unnecessary or inexpedient. The cost of such vaccination shall be borne and paid by the said district. The charges for the said work shall be first approved of by the Local Board of Health, and afterwards submitted for approval to the Lieutenant-Governor in Council, and such portion thereof as the Lieutenant-Governor in Council may hereafter determine may be reimbursed to the said district. It shall be the duty of every parent or guardian having the charge or custody of any minor under the age of sixteen years within said district, upon being notified or requested to have such minor vaccinated, to forthwith bring such minor to the office or place designated by the Local Board of Health, and to have such minor then and there vaccinated, unless the officer shall declare such vaccination unnecessary or inexpedient, and any notice or request requiring such minor to be vaccinated, or to so attend as aforesaid to be vaccinated, may be made of and directed to such parent or guardian instead of to such minor in person. In case of the neglect or refusal of any person to attend and submit to vaccination in accordance with this regulation, or of any parent or guardian responsible for the attendance of any minor as aforesaid to have such minor attend and submit to such vaccination as aforesaid, the Chairman of the Local Board of Health for the said district shall and may exercise all the powers and authority in such case in him vested under and by the Public Health Act, 1898, and all officers appointed or designated by the Local Board of Health, or whose duty it shall be to assist and aid in the carrying out of this regulation, shall for such purpose have all the powers, rights and authorities by said Act given and provided, and all persons disobeying or violating the provisions of this regulation shall be subject to the penalties by said Act provided.

REGULATION 4. Whenever in any health district within the Province other than a City or Town it shall be found by the Local Board of Health of such district that a case of smallpox exist therein it shall be the duty of such Local Board of Health to take immediate steps to isolate the disease and prevent its spreading, as far as possible, using for that purpose all the powers in them vested under and by the Public Health Act, 1898, and such Local Board shall also provide for the vaccination by the officer or officers of said Board of all persons within their district requesting to be vaccinated. It shall be the duty of the officer of such last mentioned Local Board who shall be appointed or designated for that purpose to notify and require all persons within said last mentioned district whom he shall have reason to believe likely or liable to have been infected with the contagion of smallpox to be vaccinated compulsorily if necessary under the provisions of said Act, and for the purpose of securing such compulsory vaccination in the case of such person such officer shall possess all the powers and authority given and provided by the said Act, and any such person being required by such officer as aforesaid to be so vaccinated, and refusing or failing to comply with such request, shall be subject to the penalties for such refusal provided by said Act. The cost and charges of all vaccination under this regulation shall be defrayed by the County, or in the case of the City and County of Saint John by the City and County, comprising such district, subject to reimbursement of such part thereof by the Government as the Lieutenant-Governor-in-Council may hereafter allow.

REGULATION 5. It shall be the duty of the Board of Health of each and every health district in the Province to forthwith appoint officers whose duty it shall be to vaccinate all applicants, at such places and between such hours as the Board shall determine, upon payment by the person so vaccinated of a fee not exceeding fifty cents, and to forthwith give public notice of the appointment of such officers, and of the places where and the times within which persons may be so vaccinated.
