NOTICE IS HEREBY GIVEN, That the parties hereinafter named will apply to His Honor the Lieutenant-Governor-in-Council for a grant of Letters Patent of incorporation, under the Great Seal of the Province of New Brunswick, according to the provisions of The New Brunswick Joint Stock Companies' Act, and amending Acts, incorporating the applicants and such other persons as may hereafter become shareholders in the proposed company, a body corporate and politic, under the name and for the purposes hereinafter set forth:

1. The proposed name of the company is "THE DOMINION SPECIALTY CO., (Limited)."

2. The objects and purposes for which the incorporation is sought are:

(a) To take over the wholesale and retail specialty business at present being conducted by John Harry King and Harry Leigh Beaman, with headquarters in the City of Saint John, New Brunswick, with all the agencies, connections, stock, assets, rights and credits of said company, and to pay for the same wholly or partly in paid up stock of the company to be incorporated, and to assume all or any of the obligations of said business.

(b) To establish, conduct and carry on a general wholesale and retail specialty business, and the business of wholesale and retail merchants in all kinds of goods, wares and merchandise.

(c) As principals or for any other person, firm, or corporation, as commission merchant, broker, manager, agent, factor, warehouseman, or in other capacity, to buy, sell, store, warehouse, exchange, import, export, prepare for market or otherwise handle, trade or deal in or with goods, wares or merchandise of any kind whatsoever.

(d) To carry on any other business, whether manufacturing or otherwise, which may seem to the company capable of being carried on in connection with the business of the company or calculated directly or indirectly to further the company's business, or to enhance the value or render profitable any of the company's properties or rights.

(e) To acquire by original subscription, purchase, or otherwise, and to hold, own, sell, transfer, pledge, or otherwise dispose of or encumber shares, stock, debentures, bonds or other obligations or evidence of interest in or of indebtedness of any other incorporated company or body corporate or corporation authorized to issue shares, stock, debentures, bonds or other obligations, with power, while the holder thereof, to exercise all the rights and privileges of ownership, including the right to vote thereon.

SAINT JOHN RIVER DRIVING COMPANY.

CONTRACT FOR DRIVING.

TENDERS for a contract for three years for driving the logs, timber and lumber put into the Saint John River and the Aroostook River, from the several points below mentioned, to the Sheer Booms of the said Company at Crock's Point, in the Parish of Douglas, and at McGinley's Ferry, in the Parish of Kingsclear, in the County of York, at the rates below stated, will be received by The Saint John River Log Driving Company at Fredericton until noon of the first day of April next.

Tender to state the amount that will be paid by the tenderer annually for the contract.

Contract to contain such clauses and conditions as the Directors may prescribe to secure the faithful and satisfactory performance of the work. The rates per thousand superficial feet to be paid for driving the lumber, as above specified, will be as follows:—

- 1st.—From the head of Grand Falls, 20 cents.
- 2nd.—From the mouth of Salmon River, 18 cents.
- 3rd.—From the boundary line on Aroostook River, 20 cents.
- 4th.—From the mouth of Tobique River, 16 cents.
- 5th.—From the mouth of Big Presque Isle River, 13 cents.
- 6th.—From the mouth of Becaguimic River, 13 cents.
- 7th.—From the mouth of Meduxnickag River, 11 cents.

The Directors are not obliged to accept the highest or any tender unless the same shall be satisfactory to them, as to the ability of the party tendering to carry out the contract, the price offered and all terms and conditions of the tender.

The tenderer must name two bondsmen who are ready to enter into a bond with him in the sum of Ten thousand dollars for the due performance of the contract, and the written consent of such persons to enter into the bond must accompany the tender.

In case the driving of the logs, timber and lumber be not contracted for upon tender, the same will be sold at Public Auction on the first day of April next, at 3 o'clock in the afternoon, in front of the York County Court House, in the City of Fredericton, pursuant to the provisions of Act of Assembly.
