

NOTICE OF GRANTING LETTERS PATENT

PUBLIC NOTICE IS HEREBY GIVEN, That under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the fourth day of February, A. D. 1908, incorporating Robert A. Logie, of Chatham, in the County of Northumberland and Province of New Brunswick, Accountant; Wallace W. Logie, of the same place, Accountant; Robert Murray, of the same place, Barrister-at-Law; Mary Logie, of the same place, Wife of Robert A. Logie; and Elizabeth Alice Logie, of the same place, Spinster; for the following purposes, namely:—

To operate, manage, conduct and carry on a general fishery business in the said Province of New Brunswick and elsewhere in the Dominion of Canada.

To purchase, acquire, construct, lease, hold, use, occupy and possess fishing rights, privileges, lands, buildings, factories, nets, boats, traps, canoes and all other properties, buildings, fishing gear, apparatus, appliances for the purposes herein named.

To fish for, net, catch, take, trap, cure, can, preserve, buy, barter, exchange, sell and otherwise deal in Salmon, Bass, Trout, Codfish, Ling, Hake, Herring, Smelt, Frost fish, Flounders, Lobsters, Oysters, Clams, and other fish, Crustacea and Bivalves, and to carry on and conduct a general merchandise business in connection herewith.

To acquire by purchase, lease, exchange, or otherwise, and to hold, own and possess in fee simple or in any less estate, or by way of grant or license from any Dominion, Province, Municipality, Corporation or individual, and to employ, use, control and work any lands, buildings or other property, real or personal, and any interests therein, and any easements, franchises, licenses, rights or privileges which the Company may think necessary, suitable, desirable or convenient for the purposes of its businesses; also plant, machinery, engines, horses, wagons and other vehicles, boats, canoes, nets, traps, and other fishing gear and appliances, and to sell, lease, mortgage, pledge, hypothecate or otherwise dispose of all said property, both real and personal, or any part thereof, from time to time.

To manufacture or purchase tin cans, cases, boxes, barrels and other receptacles made of tin, iron, wood or any other material or materials combined, and for the purposes aforesaid to purchase and deal in same and every material necessary for the purposes herein named, whether manufactured or unmanufactured; by the name of "MIRAMICHI FISH COMPANY, Limited; with a total Capital Stock of Ninety-nine thousand dollars, divided into nine hundred and ninety shares of One hundred dollars each.
