

NOTICE is hereby given that application will be made by the applicants hereinafter named to His Honor the Lieutenant Governor in Council for a grant of Letters Patent under the Great Seal, according to the provisions of "The New Brunswick Joint Stock Companies Act" incorporating the applicants and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for purposes hereinafter set forth:

1. The proposed name of the Company is "The Dorchester Stone Works, Ltd."

2. The objects and purposes for which incorporation is sought are:

(a) To purchase or otherwise acquire certain stone rights and privileges situate, lying and being in the County of Westmorland, and elsewhere throughout the Province of New Brunswick and elsewhere, and to develop, work, operate, manage, and control quarries for the production, taking, manufacturing, and dressing of building-stone, axe-stone, pulp-stone, and all other products capable of being made, or manufactured of stone, or stone and any other substance combined, and to sell or otherwise dispose of said products.

(b) To acquire by purchase, lease or otherwise, real estate, lands and buildings and personal property of all descriptions for the purposes of said Company and to erect upon said lands factories and buildings, plant and machinery, and to sell and mortgage the said lands, buildings, plant and machinery and personal property so acquired or erected, whenever said Company may deem it advisable to do so, and to reinvest or otherwise as deemed expedient.

(c) To sell and mortgage all or any portion of the personal property of the Company at any time whenever said Company may deem it necessary for the purposes of said Company.

(d) To establish, operate and conduct a general lumbering business and erect, purchase or otherwise acquire mills and factories and do all things necessary to supply the same with lumber of every kind and manufacture the same in all branches of wood-working.

(e) To engage in and operate plants for the manufacturing of brick, tiles, pottery, and other products made of clay, and to conduct the general business therein.

(f) To produce and accumulate by water power or otherwise electricity, electric motor force or other agency similar or otherwise, and apply the same for the production, transmission, use of the power for lighting, heating, or motive purposes.

(g) To build, buy, lease, acquire and operate boats, scows, and other vessel property, and to do all things considered indispensable or necessary for the accomplishment of the objects for which incorporation is sought as aforesaid.

(h) To construct, carry on, manufacture and make as contractors, buildings, walls, butments, bridges, all other structures of stone, brick, concrete, wood, or any other material or company of materials and for purposes aforesaid, to enter into contracts.

(i) To purchase, lease or otherwise acquire, hold and enjoy all the property franchises, rights or privileges held or enjoyed by any other individual or Company, carrying on business similar in whole or in part to that which this Company is authorized to carry on and to pay for the same either in shares of the Company or partially in shares or otherwise, with full power to lease, sub-let, sell, dispose of, or otherwise deal in all or any part of the property and rights of the said Company.

(j) To do all things whether manufactured or otherwise which may seem to the Company capable of being carried on in connection with the business of the Company or calculated directly to further the Company's business.

3. The office or principal place of business of the Company is to be at Dorchester in the County of Westmorland.

4. The amount of the Capital Stock of the said proposed Company is Ten Thousand Dollars to be divided into One Hundred shares of par value of One Hundred Dollars each.

NOTICE is hereby given, that the persons hereinafter named will apply to His Honor, the Lieutenant Governor in Council for the Grant of a Charter of Incorporation for Letters Patent under "The New Brunswick Joint Stock Companies' Act" and the Acts of Amendment thereto.

1. The proposed corporate name of the Company is to be "Boddington and Peters, Limited."

2. The objects for which incorporation is sought are:—The purchasing, acquiring and taking over as a going concern the plant, machinery and appurtenances of and belonging to the business at present carried on by Boddington and Peters, of Moncton in the County of Westmorland as Publishers, stationers, Printers and Paper-box Manufacturers, &c., together with the good will of such business with all personal property, machinery, assets and effects belonging to the said business or to the said firm of Boddington and Peters, or in any manner connected with said business and to purchase and pay for the same, either in cash or in stock of the said proposed Company as may hereafter be determined.
