TROUT FRY.

CROWN LAND OFFICE, 19th March, 1906.

EA TROUT FRY from the New Brunswick Government Hat-Chery, at Bartibog. will be ready for distribution from May 20th until about June 10th. Besides the quantities to be placed in Public Waters, a limited number will be sold to private owners of Lakes and Streams, at the rate of \$2 per thousand and expenses of transportation. These expenses will be about as follows and will cover lots of from 5000 to 20,000 fry:-
