

NOTICE IS HEREBY GIVEN, That within one month after the last publication of this notice in the Royal Gazette, application will be made to His Honor the Lieutenant-Governor-in-Council for a Charter of Incorporation by Letters Patent, under the provisions of "The New Brunswick Joint Stock Companies' Act," incorporating the applicants hereinafter named and such other persons as may hereafter become shareholders in the proposed Company, a body corporate and politic, under the name and for the purposes herein-after mentioned.

1. The proposed corporate name of the Company is "FOX SAW-TOOTH COMPANY, Limited," which is not the name of any other Company or liable to be confounded therewith.
