building of offices, the setting, erection and construction of poles and posts, stringing or putting up of wires, making of connec-tions, buying and selling of telephone instruments, wire and all other fittings, appliances and apparatus necessarily used and other https:, appnances and apparatus necessarily used and employed in carrying on a telephone business, and generally to do all and everything necessary to make, complete, support, use, work and maintain a system of telephone communication between North Head, in the Parish of Grand Manan, in the County of Charlotte and Province of New Brunswick, and Castalia, Woodward's Coye, Grand Habor, Seal Cove, Southern Head and Whitehead Island, all in the Parish of Grand Manan, in the County of Charlotte aforesaid and between such other in the County of Charlotte aforesaid, and between such other points or portions of the said Parish of Grand Manan, as the said Company may hereafter deem necessary or expedient or in its interests so to connect by telephone.

To make connection with the cable or submarine wire of any company, corporation, individual, or the Canadian Government, which now is or at any time hereafter may be laid or con-structed, connecting or to connect the Island of Grand Manan with any of the smaller islands adjacent and forming a portion of the Parish of Grand Manan, or with any portion of the main land, and with whom the said Company may hereafter be able to enter into satisfactory terms or arrangements for the purpose of establishing, securing and maintaining telephonic com-munication between some portion of the Island of Grand Manan and the smaller islands adjacent thereto, and forming a portion of the Parish of Grand Manan, or with the main land, or within any outside point not located or being in the said Parish of Grand Manan, such cable or submarine connection to be made at or from such point on the Island or Parish of Grand Manan as the said Company shall deem most suitable, convenient and expeditious for its purposes, and as the said Company may hereafter determine upon.

To purchase, lease or otherwise acquire, own or hold such lands, grants, licenses, rights, privileges, buildings, plant and such other real and personal property, and such leases, licenses, options, franchises, rights and claims of, in, to and upon the same as may be required or deemed necessary for the purpose of or incident to the business aforesaid, and to do all other things necessary for the accomplishment of the objects for which incor-portion is sought. poration is sought.

To purchase, erect and maintain, or to acquire by grant, purchase or lease what may have been already erected, the incres-sary posts, poles, wires and other works along the public streets, roads, squares, open plots of ground or highways between the above named places or in the territory above described, and for that purpose to have full power and authority given to the said Company, its successors or assigns, its agents, servants and wo a inen to enter upon the side or sides of all or any of the public roads, bridges, streets, squares, plots of ground or high ways within the said Parish of Grand Manan, and upon the same to set up, erect and construct such and so many posts, poles, or other works as the said Company in its discretion may deem necessary for making, completing, supporting, using, working and main-taining a system of communication by telephone between the said places or within the said territory; to stretch wires thereon, said places or within the said territory; to stretch withs thereon, and from time to time as often as it may be deemed necessary, to break open any part whatsoever of the said roads, streets, squares, plots of ground or highways, not however to interfere with that part of the same appropriated for the use of carriages, waggons or horses, and to keep the same open during the time necessary for the setting up, erecting, constructing, maintaining and repairing or replacing, of such posts, poles or other works used in connec-tion with the operations of the said Company.
