PUBLIC NOTICE IS HEREBY GIVEN, That under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Supplementary Letters Patent have been issued under the Great Seal of the said Province, |bearing date the eleventh day of June, A.
