We, therefore, considering that these blessings enjoyed by Our people throughout the said Dominion do call for a solemn and public acknowledgment, have thought fit, by and with the advice of Our Privy Council for Canada, to appoint, and We do appoint Thursday, the eighteenth day of October next, as a day of General Thanksgiving to Almighty God for the bountiful harvest and other blessings with which Canada has been favoured this year; and We do invite all our loving subjects throughout Canada to observe the said day as a day of General Thanksgiving.

Of all which Our loving subjects and all others whom these presents may concern, are hereby required to take notice and to govern them selves accordingly.

In TESTIMONY WHEREOF, We have caused these Our Letters to be made Patent and the Great Seal of Canada to be hereunto affixed. WITNESSES, The Honourable CHARLES FITZPATRICK, Deputy of Our Right Trusty and Right Well-Beloved Cousin the Right Honourable SIR ALBERT HENRY GEORGE, EARL GREY, Viscount Howick, Baron Grey of Howick, in the County of Northumberland, in the Peerage of the United Kingdom, and a Baronet; Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, etc., etc., Governor General and Commander in Chief of Our Dominion of Canada.

NOTICE OF GRANTING LETTERS PATENT.

PUBLIC NOTICE IS HEREBY GIVEN, That under Chapter Eighty five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the thirty-first day of August, A. D. 1906, incorporating Oscar William Nordin, of Nordin, in the County of Northumberland, in the Province of New Brunswick, Manufacturer; Bernhard Lindstrom, of the same place, Contractor and Builder; Leonard Wolfgang Just, of the same place, Chartered Accountant; Gustaf Hjalmar Hedelius, of Stockholm, Sweden, Engineer; and Gunnar Bergquist, of Stockholm, Sweden, Capitalist; for the following purposes, namely:—

To carry on and operate a general lumber business in all its branches, including the logging, driving, sawing, manufacturing and shipping of lumber of every description and kind, and the buying, selling and dealing in lumber of every kind, manufactured and unmanufactured, both wholesale and retail, and to acquire, erect and maintain mills and to operate the same for the sawing and manufacturing of lumber of all kinds.

To purchase, deal in and sell by wholesale and retail all kinds of goods, wares and merchandise necessary for the carrying on of a general mercantile business.

To build, lease, purchase or otherwise own, hold and possess in fee simple or otherwise, lands, grants, lumber lands, lumber rights, options, mills, mill privileges, milling business and rights, stores, dwelling houses, warehouses, machine shops, blacksmith shops, waterways and rights, buildings, plant and machinery, scows, wharves, barges, tugs, vessels, marine-slips, booms, dams, driving rights, franchises and privileges, and such other real and personal property as may from time to time be acquired or deemed necessary for all or any of the purposes of or incident to the business aforesaid or any part of the same, with power from time to time to encumber the same or any part thereof, and from time to time to dispose of any property both real and personal at pleasure, and to do any and all other things considered necessary for the accomplishment of the objects for which incorporation is sought as aforesaid; by the name of "THE SWEDISH PLANING COMPANY, Limited," with a total Capital Stock of Seventy-five thousand dollars divided into seven hundred and fifty shares of One hundred dollars each.

The said Stock to be divided into two classes, viz.: "A" Stock being ordinary stock, divided into 500 shares of \$100 each, and "B" Stock being Preference Stock, divided into 250 shares of \$100 each. The "B" Stock shall confer on the holders thereof the right to the fixed cumulative preferential dividend at the rate of seven per centum per annum on the amount paid up thereon from the date of such payment, and to a further dividend or pro rata distribution of ten per cent of the net profits available for distribution remaining after the payment of the said preferential dividend of seven per cent, such dividend to be paid yearly on such day as the Directors of the Company may determine but if any and so often as in any year the said net profits of the Company shall be insufficient to pay thereout a dividend of seven per cent, on said preference shares, then so much of the said deficiency shall be a fixed first charge upon the next subsequent and ensuing net profits of the Company, and shall be paid subsequently out of the first available net profits before any dividend be paid out or set apart for the Common Stock or for any later dividend upon Preference Shares. The said Preference Shares shall also confer on the holder thereof, in case the Company shall be wound up or its assets otherwise distributed, the right to have the surplus assets applicable for distribution among the shareholders, applied first in payment of the unpaid amount of any dividend due on the proportion thereof accrued on such Preference Shares, and next in payment of the Capital paid up on such Preference Shares, both before any portion of such surplus assets is distributed among the
