(2) To construct, build, equip, maintain and operate elevators, for elevating and storing wheat, grain and other produce with the requisite engines, plant, machinery and appliances therefor, and generally to carry on an elevator and storage business and to trade and deal in wheat, grain and other produce and the products thereof.

(9) To provide board, lodging, clothing, provisions and all supplies generally, to those engaged in or about any of the Company's works, docks, wharves, warehouses, factories, elevators, yards, vessels and businesses, and on or about the properties of the Company and to contract for the providing of the same; and to build, construct, equip and maintain and lease or operate, hotels, boarding houses, dwelling houses, barns, out-buildings, and conveniences of every description, and the burners of the contract of the contr and to buy, sell, manufacture, produce, and deal in all kinds of goods, wares, provisions, stores, supplies, machinery, implements, appliances, chattels and effects used, consumed and required by the Company, or its employees, workmen and servants, and by the steamers, vessels, dredges, barges, fishermen, merchants, companies, and persons that make use of and believe the companies. and do business at, on, or about the Company's docks, wharves, elevators, factories, yards, farms, and other buildings and properties.

(10 To acquire by purchase, lease, exchange or otherwise,

(20) To accept in payment of any work done by the Company, or in payment of money due to the Company, stocks, shares, bonds, debentures or other securities of any com-

pany. (21) To aid in any manner any corporation, whose shares of capital stock, bonds or other obligations are held, or are in any manner guaranteed by the Company, and to do any acts or things for the preservation and protection improvement or enhancement of the value of any such shares of capital stock, bonds, or other obligations, to do any and all acts and things tending to increase the value of any of the property at any time, owned, held, or controlled by the Company

To lease, sell, improve, manage, work, develop, change, hypothecate, mortgage, turn to account, or otherwise dispose of, or deal with, the real and personal property franchises, rights, and assets of the Company or any part thereof, for such consideration as the Company may deem fit, including shares, debentures or securities of any company.

(25) To apply for, obtain, register, purchase, lease or license, on royalty or otherwise acquire and hold, use, own, operate and introduce, and to sell, assign or otherwise dis-pose of any trade marks, trade names, inventions, patents of inventions, improvements and processes, under registration or otherwise, and to use, exercise, develop, grant, licenses in respect of, or otherwise turn to account any such trade marks, trade names, inventions, patents, licenses, processes

and the like, or any such other property or rights.

(26) To make advances and grant loans on ships and vessels, and on goods, wares, merchandise, live stock, produce and effects, carried or to be carried in any vessel, and on goods, wares, merchandise, produce, live stock and personal property of every description, stored, warehoused, boarding or feeding in any of the warehouses, elevators, stockyards or farms, owned or operated by the Company or by any company or persons or in connection with the Company's properties or
