

NOTICE is hereby given that the persons hereinafter mentioned will apply to His Honour, the Lieutenant Governor of New Brunswick in Council for the grant of a Charter of Incorporation by Letters Patent under the New Brunswick Joint Stock Companies' Act, and Acts in amendment thereof.

The proposed Corporate name of the Company is to be "The S. J. McGowan Manufacturing Company, Limited."

The objects for which incorporation is sought are:—

1. To purchase, acquire and take over the business now carried on by Samuel J. Dearborn, of the same place, Married Woman; Louise C. Dearborn, of the same place, Widow; Harry N. Dearborn, of the same place, Gentleman; and Clarence H. Ferguson, of the same place, Barrister-at-Law; for the following purposes, namely:—

To purchase or otherwise acquire and to take over the business of wholesale grocer and manufacturer of baking powders, coffees, spices and flavoring extracts, and all the other lines of business now carried on by Frederick R.
