NOTICE OF GRANTING LETTERS PATENT.

PUBLIC Notice is hereby given, that under Chapter Eighty-five of the Consolidated Statutes of New Brunswick, 1903, and amending Acts, Letters Patent have been issued under the Great Seal of the said Province, bearing date the first day of June, A. D. 1909, incorporating Fred E. Law, Merchant; Oliver E. Akerley, Dealer; Frank E. Williams, Merchant; Alexander W. MacRae, Barrister-at-Law; and George Swanton, Stevedore; all of the City of Saint John, in the City and County of Saint John, and Province of New Brunswick, for the following purposes, namely:

To purchase the export business at present carried on in the City of Saint John by F. E. Williams Company, Limited, and to pay for the same in cash or paid-up capital stock of the proposed Company, or part one way and part the other, as may be agreed upon.

To carry on a general wholesale and retail exporting and importing business and to buy, sell and deal in every and all kinds of goods, wares and merchandise.

To construct, build, acquire, purchase, exchange, lease, charter, operate, sell, mortgage and hypothecate ships, steamers, barges, lighters, and vessels of every nature, for the purpose of carrying on the business of the Company.

To purchase, lease and otherwise acquire, sell, mortgage or hypothecate lands and land covered with water, rights, privileges and easements, and to purchase, acquire, construct, maintain and operate docks, wharves, warehouses, canning factories, storage, cold storage and frost proof warehouses, and generally to carry on a warehouse, storage, brokerage, agency and factors business.

To promote or assist in promoting, and to become a shareholder in any subsidiary, allied or other company carrying on or having for its object the operation of any business similar to that of this Company, or useful to, or which can be operated in connection therewith, and to enter into any arrangements for sharing profits, union of interest, joint adventure, reciprocal concessions, or otherwise, with such company; and to hold, sell, reissue, with or without guarantee, or otherwise deal in the same.

To acquire the good will, property, rights and assets, and assume the liabilities of any person, firm or company, indebted to the Company, or carrying on or transacting any business similar to that conducted by the Company, and to pay for the same in cash, or in securities of the Company, or otherwise.

To take or otherwise acquire and hold shares and securities in any other companies authorized to do any business which the Company is authorized to carry on, or carrying on any business capable of being conducted so as to directly or indirectly benefit the Company.

To accept in payment of any work done by the Company or in payment of money due to the Company, stock, shares, bonds, debentures or other securities of any company.

To lease, sell, improve, manage, work, develop, exchange, hypothecate, mortgage, turn to account, or otherwise dispose of or deal with the real and personal property, franchises, rights and assets of the Company or any part thereof, for such consideration as the Company may deem fit, including shares, debentures or securities of any company.

To make advances and make loans on goods, wares and merchandise, produce and effects, carried or to be carried in any vessel, and on goods, wares, merchandise, produce and personal property of every description, stored or warehoused by the Company, or in connection with the Company's property or business, and to customers and others having dealings with the Company.

To carry on and conduct any other business capable of being carried on in connection with any of the above specified businesses, which may seem calculated to enhance or render profitable any of the company's property or rights.

The Company hereby incorporated shall be liable for the debts and obligations of the said F. E. Williams Company, Limited, existing at the time of taking over the said property and may be sued for the same in any Court of competent jurisdiction, by the name of "St. John Produce Company, Limited," with a total capital stock of Forty-nine thousand dollars divided into Four hundred and ninety shares of One hundred dollars each, with its head office at the City of Saint John.
