Now Know Ye that We do, by and with the advice of Our Privy Council for Canada, proclaim and declare that Tuesday, the twenty-fourth day of May, in the year of Our Lord one thousand nine hundred and ten, is hereby fixed as the day for the celebration of Our said Birthday. Nevertheless it is Our pleasure that the usual salute in honour of Our said Birthday shall be fired at all Military Stations on the ninth day of November next.

notice and to govern themselves accordingly. In Testimony Whereof, We have caused these Our Letters to be made Patent, and the Great Seal of Canada to
